Hon'ble Deputy Chief Minister and Minister for Education has conducted the meeting as a follow up of the meeting on 10.01.2018 and enquired about the action taken. While initiating the meeting the Hon'ble Deputy Chief Minister requested the CEO, BILT, Kamalapuram to inform the action taken on the decision taken during the meeting held on 10.01.2018.

The CEO, BILT has informed that as decided in the last meeting one month salary was paid by Sankranthi. Further another one month salary is being transferred to the Kamalapur branch today and will be remitted to the workers today. Further the CEO informed that the Board meeting was conducted during February 2018 and the Board decided in principle to run the plant by converting to paper grade pulp. The Board felt that there were two major problems. 1) Huge investment is required, 2) As the plant has been closed for a long time, it requires renovation.

The Hon'ble Deputy Chief Minister after discussing with the Union Representatives has directed the CEO to take action as follows:-

- 1) While observing that the action plan for settling the dues for deceased and retired employees was not furnished as committed during last meeting. It was directed that the dues shall be settled within one month either through Insurance amount or by making alternate arrangement.
- 2) The Management should take a policy decision on whether they want to revive the plant or not and communicate the same in writing by 18.04.2018. In case the Management decides to revive the plant they shall submit their action plan/proposal within two months i.e. by 03.06.2018.
